Résumé <i>Abstract/Resumen</i>	(abstract excerpted from the article) “Collaborations are increasingly important to non-profit organisations. This paper extends our understanding of how collaborations are governed. It presents a conceptual framework drawn from existing research and compares this literature to research on non-profit organisational governance. An application of the framework to two case studies highlights the dynamic and emergent quality of collaborative governing systems. Changes in governance structures and processes are driven by their external environments, trust-building and collective leadership processes, and the development of different types of governing rules. The paper concludes with implications for research on governance in collaborative settings as well as for the study of non-profit, organisational governance.”

Résumé <i>Abstract/Resumen</i>	(abstract excerpted from the article) “In the framework of public sector reform and the recently popularized concept of a “new public sphere,” attention has been focused on the significance and effectiveness of public private partnership (PPP). However, the smooth operation of PPP practice is yet to be realized, and the nonprofit sector still faces challenges in becoming a government partner in public service provision. We examine government behavior in PPP practice and its stance on partnership practice and collaborative relations with contemporary nonprofit organizations. Through public finance statistics and a unique set of variables, an empirical analysis reveals that the existence of nonprofit organizations (NPOs) positively affects local government decisions to implement PPP practices and outsource to NPOs for public service provision. Other influential factors include local governments’ budgetary conditions, attitudes towards public administration and finance, local chief executive characteristics, and neighboring local government behaviours.”

Résumé <i>Abstract/Resumen</i>	(abstract excerpted from the URL cited above) ‘By studying two municipalities in Tokyo that have different environmental conditions in terms of resource allocations, this article examines whether the relationship between for-profit and nonprofit organizations providing long-term care has changed since the introduction of the Long-Term Care Insurance (LTCI) system in Japan. LTCI allocates most resources based on process control, and thus access to resources is easier by conforming to regulations and standards. Findings indicate that for-profit providers behave like nonprofit providers in such an environment. However, when commercialized services are provided besides legally defined LTCI services, outcome control comes into effect in addition to process control. This study finds that the differences between for-profit and nonprofit providers are maintained in this type of environment. Theoretical as well as policy and management implications are discussed, and this article concludes with the directions for future research.’

Résumé <i>Abstract/Resumen</i>	(abstract excerpted from the URL cited above) “This article addresses the subject of management control and tries to create a performance measurement system for social enterprises, that is, how to measure success. Three reference fields for management are analyzed: (a) economic-financial performance, linked to the determination of general performance (profits, value added, etc.) and analytic results (production-cost of services, efficiency indicators, etc.); (b) social effectiveness, to measure the quantity and quality of work undertaken and to identify its impact on the intended beneficiaries and the community; and (c) institutional legitimacy, verifying conformity with law and mission statement. In integrating these aspects, we propose a multidimensional controlling framework that is appropriate to the management of a social enterprise. We try to demonstrate the validity of the theoretical model through the illustration of an Italian empirical case: the work integration social enterprise “Ulisse.””

The report profiles data from 140 of 295 social enterprises in both provinces (Alberta and British Columbia, Canada) gathered in the spring and summer of 2010. Résumé <i>Abstract/Resumen</i>	(abstract excerpted from the URL cited above) “Drawing on data from an in-depth case study of an embryonic social enterprise, this paper explores how social enterprises can utilise the multiple identities of social enterprise to access start-up funding. The social entrepreneur exhibited multiple organisational faces to external stakeholders in order to acquire resources. However, resource holders were not passive recipients of these managed impressions. Each had a strategic interest in the social enterprise being presented in a particular way and exerted coercive pressure on the social enterprise to conform to these co-constructed impressions. Utilising organisational impression management helped the social enterprise resist these coercive pressures.”

Résumé <i>Abstract/Resumen</i>	(abstract excerpted from the URL cited above) “Nonprofit organizations worldwide are confronted with an increasing demand for accountability and improved financial transparency. Financial reporting by nonprofit organizations is no longer an exception; it has become a rule. The usefulness of a financial report to an organization's stakeholders depends on its quality. The latter is safeguarded by reporting standards as well as the commitment of the organization to fully implement these standards. Although resource dependence and coercive isomorphism have been used in earlier nonprofit organization research, no empirical research has linked these theories to compliance with financial reporting standards. Using a unique setting in which a large number of (very) large Belgian nonprofit organizations are confronted with far-reaching changes in financial reporting regulations, the effect of resource dependence and coercive isomorphism on accounting and financial reporting compliance is documented.”

Résumé <i>Abstract/Resumen</i>	(Resumen proveniente del artículo) “Con una aproximación teórica a la innovación y a las empresas sociales, se analizan algunas de las experiencias relevantes surgidas en la empresa social; con ello se busca establecer si la empresa social puede ser considerada como una forma de organización innovadora. Las experiencias en el mundo toman forma a partir de las aportaciones surgidas durante el siglo XIX; siendo las ideas de Robert Owen el punto de partida para la conformación de la primera cooperativa de consumo, la que fue integrada por hombres emprendedores a los que se les conoció como los Pioneros de Rochdale. Poco tiempo después, surgen las cajas de ahorro establecidas por Friedrich Wilhelm Raiffeisen y Hermann Schulze-Delitzsch en Alemania. Durante el siglo XX son ubicadas en Canadá dos experiencias relevantes: el movimiento de Antigonish y las cooperativas de ahorro y crédito Desjardins. Igualmente, en España surge la importante experiencia de las empresas de Mondragón. Emprendimientos más recientes surgen en Brasil con las incubadoras tecnológicas de cooperativas; en Bangladesh destacan las empresas sociales de Yunus; en Argentina y Uruguay se ubica a las empresas recuperadas y en México las cooperativas de producción y de ahorro y crédito. Se concluye que en sí mismas las empresas sociales son ejemplo de innovación, creando valor económico y valor social para sus socios y las comunidades en donde se desarrollan. Además de que en diferentes épocas, con su conformación se ha contribuido a la solución de problemáticas comunes que han aquejado a diversos sectores de la población en el mundo.”

Résumé Abstract/Resumen	(abstract excerpted from the URL cited above) “The election of a new coalition government in the United Kingdom (UK) in May 2010 has led to a change of direction in third sector policy within England, referred to by the new government as 'building the Big Society'. The immediate legacy for this new policy environment in the policies of the previous government and the politics of the election campaign is summarised. The key commitments of the Big Society agenda are outlined and the broader ideological context of this critically explored. Some of the implications for third sector policy and practice are identified and the paper closes by questioning whether the Big Society agenda may threaten third sector unity.”

Résumé Abstract/Resumen	(abstract excerpted from the URL cited above) “Substantial research has been conducted concerning the efficiency and efficacy of different modes of public service delivery and contracting out. This article develops a model of service delivery choice taking into account the distinction between public, private and non-profit organizations and the characteristics of the service to be delivered. Transaction Costs Economics has mainly debated the attributes of the technology involved in production and the required investments. In this article, considerations on the organizational nature of the actors participating in the process are added to this framework, pointing out that features of the internal structure and of the external mode of social control of organizational forms make them more suitable for providing certain services rather than others. The model is based on two dimensions: incentives power and authority types. Evidence from the contracting-out debate is used for discussing the implications of the model for the feasibility and efficiency of organizations in the service delivery. Politicians and public managers daily face the challenge of choosing the

	<p>best way to manage the delivery of public services to the citizenship. Our research aims at supporting this decisional process, taking into account the nature of the service and of the organization delegated to deliver the service. The incentives provided by different organizational structures and the authority types involved should be considered. Our model suggests that low or high political authority and low- or high-powered incentives can lead to the contractualization to private, public or non-profit organizations. When incentives are high-powered and political authority is low, the service delivery should be privatized."</p>
