*Abstract excerpted from the article:* “During disasters, partnerships between public and nonprofit organizations are vital to provide fast relief to affected communities. This article develop a process model to support a performance evaluation of such intersectoral partnerships. The model includes input factors, organizational structures, outputs and the long-term outcomes of public-nonprofit partnerships. These factors derive from theory and a systematic literature review of emergency, public, nonprofit, and network research. To adapt the model to a disaster context, it conducted a case study that examines public and nonprofit organizations that partnered during the 2010 Haiti earthquake. The case study results show that communication, trust, and experience are the most important partnership inputs; the most prevalent governance structure of public-nonprofit partnerships is a lead organization network. Time and quality measures should be considered to assess partnership outputs, and community, network, and organizational actor perspectives must be taken into account when evaluating partnership outcomes.”

Recent years have seen an increasing research and policy interest in the nature of civil society activity at the local level. In contributing to this, it argues that greater attention is paid to how relationships between civil society actors and organisations are shaped by local context. Drawing on the accounts of key individuals in a rural locality, the papers identify how the actors who have skills and experiences in running organisations relate to people in a disadvantaged, former slate-quarrying village in which such capacities are perceived to be lacking. Such relations between key actors, and between key actors and local people, are overlaid by divisions of class, language and incomer status, producing a contested field. It argues that these tensions have significant implications for statutory area-based regeneration projects aimed at community empowerment, which, in the worst instances, work to reaffirm rather than overcome such divisions.”

The paper is developed from a conceptual rationale of social enterprises as private businesses that are not primarily driven by financial profit but by a combination of economic and social objectives, whereby stakeholders from various institutional spheres (market, state and civil society) are increasingly involved. Based upon this, the paper analyses and synthesizes the main findings from 20 cases investigated during fieldwork conducted in China. However, such partnerships often raise serious concerns about transparency and accountability. While municipal governments across Canada have tried to increase public participation in local affairs, PPPs can impede such efforts. This article presents a case study of the Lansdowne Park PPP redevelopment in the City of Ottawa. We focus on how transparency and citizen engagement have been compromised and circumvented and link to broader issues of how to balance the privileged status of business and the demands for commercial confidentiality with the public interest, transparency, and citizen engagement in projects that use PPPs. The article concludes by arguing that some projects and some conditions can render the use of PPPs inappropriate and counterproductive in terms of both effectiveness and the basic principles of good governance."*

First, provincial sector growth is compared across several indices to establish this gap’s empirical scope and scale. Second, historical research and fieldwork findings are used to illuminate the gap’s origins and its historical significance. The article concludes that the development gap has been largely driven by bloc formation and dissolution—the historic erosion of Saskatchewan’s traditional, agrarian-cooperative bloc and the renewal and expansion of Québec’s social economy bloc.”

*Abstract excerpted from the URL cited above:* “This research compares perceived organizational support to work–family balance measures and policies in various work environments to determine whether the organizational context can be a mediating variable or whether the social economy sector, with its mission and management approach (participatory decision-making) might have an influence on organizational support to work–family balance. We studied the social economy sector and compared findings with three other sectors in the public service that have a public service mission but not the same democratic or participatory management mode: a metropolitan police service, social work, and nursing, all in the same city. Our research identifies many significant differences between the four sectors, essentially owing to the characteristics of the social economy sector. In addition to our quantitative research, we conducted interviews (36) in the sector and results indicate that the specificity of the social economy sector, i.e. mission and management mode, explain the overriding concern for work–life balance in the social economy sector.”
